

2021 Super Cash Giveaway – Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- PROMOTION OVERVIEW:** The 2021 Super Cash Giveaway (the "Promotion") is sponsored by Gold Rush Amusements, Inc. ("Gold Rush Gaming") and participating Gold Rush Gaming locations listed in Appendix A (each, a "Participating Location" and together with Gold Rush Gaming, the "Sponsors"). Gold Rush Gaming's principal place of business is located at 5277 Trillium Blvd. Hoffman Estates, IL 60192 (the "Main Office"). The principal place of business for each of the Participating Locations is also set forth on Appendix A.
- ELIGIBILITY:** The Promotion is open to guests of each Participating Location who are residents of the United States of America who are twenty-one (21) years of age or older at the time of entry and who are located in Illinois at the time of the participation in the Promotion ("Eligible Entrants"). Guests may be required to show a valid identification card (either a driver's license or other government issued photo identification) with the guest's picture, name, address and age to participate. The following persons are ineligible to participate in the Promotion and/or to win a prize, even if they otherwise meeting the definition of an Eligible Entrant: employees, officers, directors, agents, owners, successors and assignees of Sponsors, their respective *parent, subsidiaries and affiliated companies, any advertising, promotional agencies, or other entity otherwise involved in the creation, administration or fulfillment of the Promotion* (all of the above italicized entities collectively referred to herein as "Promotion Parties"), and the immediate family members (defined as spouse, parent, child, sibling, or grandparent; whether biological adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as the Eligible Entrant at any time during the Promotion Period) of such Promotion Parties.
- PROMOTION DATES:** The Promotion will begin on Saturday, May 1st, 2021 at 12:01am or at the start of the business day for each specific Participating Location and will end on Monday, May 31st, 2021 at 7:00pm (the "Entry Period"). The Grand Prize Drawing will take place on Friday, June 11th, 2021 at 5:00pm at Gold Rush Gaming's Main Office. Winners need not be present to win. All times for this Promotion reference Central Standard Time.
- SWEEPSTAKES PROCEDURES.** During the Entry Period, each Participating Location will have Entry Cards (described below) available for distribution to Eligible Entrants. Each person who enters the Promotion via an Entry Card is referred to herein as a "Participant". Each Entry Card must include the guest's (a) first and last name; (b) primary telephone number; (c) email address; and (d) identify the name of the Participating Location (subparts (a) through (d) are referred to herein as the "Required Participant Information"). An Entry Form is available by visiting a Participating Location and requesting such form from the attendant on duty, while supplies last. The Required Participant Information must be complete, accurate and current as of the date of the entry. A Participant is permitted one entry per person per day per Participating Location. Participant is required to complete all fields on the Entry Card (image

below). Participant is responsible for depositing the Entry Card in the box or bowl provided upon completion. Entry Cards will be accepted during normal business hours of each Participant Location during the Entry Period. In the event that a Participant does not comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsors, such Participant may be disqualified from the Promotion. Moreover, at the sole determination of the Sponsors, all of that Participant's entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prize.

Following the completion of the Entry Period, Entry Cards will be collected by a representative of Gold Rush Gaming and transported to Gold Rush Gaming's Main Office. All Entry Cards are the property of the Sponsors and will not be returned. The following outlines the prize distribution. There will be a total of nineteen (19) winners during the Promotion.
7. **PRIZES, PRIZE VALUES, ODDS OF WINNING AND COLLECTING PRIZES.** The following outlines the prize distribution:

The odds of winning the 2nd Place through 5th Place prizes is dependent entirely on the number of entries receiving during the Entry Period in the applicable Region. The odds of winning the Grand Prize is dependent entirely on the aggregate number of entries received during the Entry Period. 8. **PRIZE WINNERS NOTIFICATION PROCEDURES:** On Friday, June 11, 2021 at approximately 5:00pm, a designated team member or manager from Gold Rush Gaming will select at random a total of nineteen (19) winners (“Draw Date”). To select the 2nd through 5th Place winners, all entries from the Participating Locations in each Region will be combined into one drawing bin for a total of three drawing bins: Northern, Southern and Western. A representative of Gold Rush Gaming will select six (6) winners from each Region, beginning with the three (3) 5th Place winners, followed by one (1) 4th Place winner, then one (1) 3rd Place winner, and one (1) 2nd Place winner. After a total of eighteen (18) winners have been selected from the separated bins, all entries will be combined for the Grand Prize drawing. A Gold Rush Gaming representative will select at random one (1) winner for the Grand Prize. Winners will be announced on Facebook Live from the Gold Rush Gaming Facebook Page. Winners do not need to be present or viewing Facebook Live at the time of the drawing to win. Winners will also be notified of their selection via telephone and at the e-mail address provided on the entry card (the "Winner Notification"). Receiving a prize is subject to verification of eligibility and compliance with these Official Rules. If a Winner (i) has not responded to Sponsor's email or telephone call within fourteen (14) days of the Draw Date; (ii) does not fulfill the eligibility requirements; (iii) does not adhere to these Official Rules; and/or (iv) does not provide the required identification to Sponsor, the Winner will be disqualified. Any prizes not claimed within 14 days of the Draw Date will be forfeited and will not be awarded. A Gold Rush Representative will set a date and time with each Winner to hand deliver each applicable prize at a Participating Location. Before collecting or otherwise accepting any prize, a Winner must execute an “Affidavit of Eligibility and Liability/Publicity Release” and any required tax documents, including a W-9.

9. **CONDITIONS:** All taxes, costs, expenses, title and licensing fees on Prizes are the sole responsibility of each Winner. Each Winner will be required to provide tax information and will be sent an IRS Form 1099. Each Winner is solely responsible for reporting and paying all applicable federal, state and local taxes related to the prize. Entry Cards and prize winnings are not transferable. Sponsors are not responsible for lost, stolen or damaged Entry Cards. Only original Entry Cards are allowed. No copies or reproductions allowed.

10. MISCELLANEOUS:

- a. By entering, Participant unconditionally agrees to be bound by these rules and the decisions of the Sponsors, which shall be final. The Sponsors reserve the right to disqualify any Participant or Winner who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner. In the event of a discrepancy between these Official Rules and any creative/collateral materials relating to the Promotion, these Official Rules will prevail.

12. **Use of Disclosed Information.** Information transmitted to Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each Winner's name, Required Participant Information, biographical information and/or likeness for online posting and /or any other written or photographic advertising and publicity without additional compensation. Further, by entering the Promotion, the Participant is granting the Sponsors permission to use his/her contact information to (i) contact him/her regarding a Prize and (ii) provide him/her with marketing or other informational materials related to the Sponsors.
13. **ARBITRATION:** Except where prohibited by law, as a condition of participating in this Promotion, Participant agree that (a) any and all disputes and causes of action arising out of or connected

with this Promotion, or any prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the Sponsor; (b) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (c) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will a Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Participant's actual out-of-pocket expenses (i.e., costs associated with participating in this Promotion), and Participant further waives all rights to have damages multiplied or increased.

14. **CHOICE OF LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Illinois, USA. This Promotion is subject to compliance with the Illinois Video Gaming Act and the rules and regulations promulgated thereunder. Sponsors reserve the right to revise these rules to comply with applicable law.
