## 2021 Holiday Home Makeover – Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. **PROMOTION OVERVIEW:** The 2021 Home Holiday Makeover (the "Promotion") is sponsored by Gold Rush Amusements, Inc. ("Gold Rush Gaming") and participating Gold Rush Gaming locations listed in Appendix A (each, a "Participating Location" and together with Gold Rush Gaming, the "Sponsors"). Gold Rush Gaming's principal place of business is located at 5277 Trillium Blvd. Hoffman Estates, IL 60192 (the "Main Office"). The principal place of business for each of the Participating Locations is also set forth on Appendix A.
- 2. **ELIGIBILITY:** The Promotion is open to guests of each Participating Location who are residents of the Illinois, Wisconsin or Indiana and who are twenty-one (21) years of age or older at the time of entry ("Eligible Entrants"). Guests may be required to show a valid identification card (either a driver's license or other government issued photo identification) with the guest's picture, name, address and age to participate. The following persons are ineligible to participate in the Promotion and/or to win a prize, even if they otherwise meeting the definition of an Eligible Entrant: employees, officers, directors, agents, owners, successors and assignees of Sponsors, their respective parent, subsidiaries and affiliated companies, any advertising, promotional agencies, or other entity otherwise involved in the creation, administration or fulfillment of the Promotion (all of the above italicized entities collectively referred to herein as "Promotion Parties"), and the immediate family members (defined as spouse, parent, child, sibling, or grandparent; whether biological adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as the Eligible Entrant at any time during the Promotion Period) of such Promotion Parties. - 3. **PROMOTION DATES:** The Promotion will begin on Monday, November 1st, 2021 at 12:01am or at the start of the business day for each specific Participating Location and will end on Friday, December 3<sup>rd</sup>, 2021 at approximately 5:00pm (the "Entry Period"). The Grand Prize Drawing will take place on Friday, December 10<sup>th</sup>, 2021 at 4:00pm at a site to be announced at goldrushgaming.com/promotions/holidayhomemakeover no later than December 3<sup>rd</sup>, 2021. Winners need not be present to win. All times for this Promotion reference Central Standard Time.
- 4. **SWEEPSTAKES PROCEDURES**: During the Entry Period, each Participating Location will have Entry Cards (described below) available for distribution to Eligible Entrants. Each person who enters the Promotion via an Entry Card is referred to herein as a "Participant". Each Entry Card must include the guest's (a) first and last name; (b) primary telephone number; (c) email

address; and (d) identify the name of the Participating Location (subparts (a) through (d) are referred to herein as the "Required Participant Information"). An Entry Form is available by visiting a Participating Location and requesting such form from the attendant on duty, while supplies last. The Required Participant Information must be complete, accurate and current as of the date of the entry. A Participant is permitted one entry per person per day per Participating Location. Participant is required to complete all fields on the Entry Card (image below). Participant is responsible for depositing the Entry Card in the box or bowl provided upon completion. Entry Cards will be accepted during normal business hours of each Participant Location during the Entry Period. In the event that a Participant does not comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsors, such Participant may be disqualified from the Promotion. Moreover, at the sole determination of the Sponsors, all of that Participant's entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prize.

PRIZE WINNERS' NOTIFICATION PROCEDURES: Beginning Friday, November 5th, 2021, and continuing each consecutive Friday until the completion of the Entry Period on Friday, December 3rd, 2021, at or around 5:00pm, a designated establishment team member or will select at random a winner and notified via telephone. On Friday, December 10<sup>th</sup>, 2021, at approximately 4:00pm, a designated spokesperson for Gold Rush Gaming will select at random, to be broadcast LIVE on Facebook Live, a total of three (3) winners ("Draw Date") to determine the Grand Prize winners. Winners do not need to be present or viewing Facebook Live at the time of the drawing to win. Winners will also be notified of their selection via telephone and at the e-mail address provided on the entry card (the "Winner Notification"). If a Winner (i) has not responded to Sponsor's email or telephone call within three (3) days of the Draw Date; (ii) does not fulfill the eligibility requirements; (iii) does not adhere to these Official Rules; and/or (iv) does not provide the required identification to Sponsor, the Winner will be disqualified. - 14. **CHOICE OF LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Illinois, USA. This Promotion is subject to compliance with the Illinois Video Gaming Act and the rules and regulations promulgated thereunder. Sponsors reserve the right to revise these rules to comply with applicable law.
