- 2. ELIGIBILITY: This Promotion open to patrons of each Participating Location that meet the following requirements: (i) if participating in this Promotion and a Participating Location has opted to utilize the Kiosk Entry (as defined below and reflected on Exhibit A), patron must enroll or be enrolled in the Gold Rush Player Rewards Program (regardless of whether such patron has or intends to play a Video Gaming Terminal or otherwise make a purchase); (ii) who are a resident of Illinois, Wisconsin, Iowa or Indiana; and (iii) who are twenty-one (21) years of age or older at the time of entry (an "Eligible Entrant").  - ii. - a. The number of Winners will depend on the number of Participating Locations. There will be one (1) Winner for each Participating Location. Each Winner will be eligible to receive the following:
