



“HOWLING FORTUNES PROMOTION” OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING INTO THIS PROMOTION, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES, WHICH CONSTITUTE A CONTRACT, SO READ THEM CAREFULLY. IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS CONTRACT, DO NOT ENTER THIS PROMOTION.

1. **HOWLING FORTUNES PROMOTION OVERVIEW:** The “HOWLING FORTUNES PROMOTION” (this “Promotion”) is sponsored by Gold Rush Amusements, Inc. (“Gold Rush Gaming”), IGT, and each of the locations set forth on Exhibit A, attached hereto (each, a “Participating Location”, collectively the “Participating Locations,” and together with Gold Rush Gaming and IGT, the “Sponsors”). Gold Rush Gaming’s principal place of business is located at 5277 Trillium Blvd., Hoffman Estates, IL 60192 (“Gold Rush Gaming’s Main Office”). IGT’s principal place of business is located at 10 Memorial Boulevard, Providence, RI 02903 USA. The principal place of business for each Participating Location is reflected on Exhibit A. This Promotion consists of three (3) separate giveaways: (1) The Grand Prize Giveaway; (2) the Social Media Giveaway; and (3) the Gold Standard Rewards Giveaway (each, as defined below). The Grand Prize Giveaway and the Social Media Giveaway will be offered at each Participating Location. The Gold Standard Rewards Giveaway is offered at Participating Locations with a GSR Kiosk (as defined below), which is reflected on Exhibit A.

2. **ELIGIBILITY:** The Promotion is open to patrons of each Participating Location (for the Gold Standard Rewards Giveaway, each Participating Location with a GSR Kiosk) that meet the following requirements: (i) if participating in the Grand Prize Giveaway and a Participating Location has opted to utilize the Kiosk Entry (as defined below and reflected on Exhibit A) or participating in the Gold Standard Rewards Giveaway, patron must enroll or be enrolled in the Gold Standard Rewards Player Rewards Program (referred to herein as the “GSR Program”) (regardless of whether such patron has or intends to play a Video Gaming Terminal or otherwise make a purchase); (ii) if participating in the Social Media Giveaway, maintain a valid personal account with Instagram; (iii) who are a resident of Illinois, Wisconsin, Iowa or Indiana; and (iv) who are twenty-one (21) years of age or older at the time of entry (an “Eligible Entrant”). For the avoidance of doubt, if participating in the Grand Prize Giveaway at a Participating Location that has opted to utilize the Ballot Entry (as defined below and reflected on Exhibit A), enrollment in the GSR Program is not required. Patrons may be required to show a valid identification card (either a driver’s license or other government-issued photo identification) with the patron’s picture, name, address and date of birth at the time of entry to participate. Each person who enrolls in the Promotion is referred to herein as a “Participant.” The following persons are ineligible to participate in the Promotion and/or to win a prize, even if they otherwise meet the definition of an Eligible Entrant: employees, officers, directors, agents, owners, successors and



assignees of the Sponsors, their respective *parent, subsidiaries and affiliated companies, any advertising, promotional agencies, or other entity otherwise involved in the creation, administration or fulfillment of this Promotion* (all of the above italicized entities collectively referred to herein as “Promotion Parties”), and the immediate family members (defined as spouse, parent, child, sibling or grandparent; whether biological, adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as the Eligible Entrant at any time during the Promotion Period, as defined below) of such Promotion Parties. Each Participant is limited to creating one (1) account for the GSR Program.

3. **PROMOTION DATES:** The Grand Prize Giveaway will begin on Monday, September 25, 2023, at approximately 12:01 a.m. CST and conclude on Thursday, October 26, 2023, at approximately 12:00 p.m. CST (the “Grand Prize Giveaway Period”). The Social Media Giveaway will begin on Monday, September 25, 2023, at approximately 12:01 a.m. CST and conclude on Monday, October 30, 2023, at approximately 11:45 a.m. CST (the “Social Media Giveaway Period”). The Gold Standard Rewards Giveaway will begin on Monday, September 25, 2023, at approximately 12:01 a.m. CST and conclude on Wednesday, October 18, 2023, at approximately 11:00 a.m. CST (the “Gold Standard Rewards Giveaway Period”). The Grand Prize Giveaway Period, the Social Media Giveaway Period and the Gold Standard Rewards Giveaway Period are collectively referred to as the “Promotion Period”).

4. **PROMOTION PROCEDURES:**

- a. Grand Prize Giveaway: Patrons may enter the grand prize giveaway (the “Grand Prize Giveaway”) during each Participating Location’s regular business hours as follows:
 - i. At Participating Locations that participate in the GSR Program and have opted to utilize the GSR Program Kiosk (“GSR Kiosk”) for entry purposes, as reflected on Exhibit A, patrons shall enter on-site via the GSR Kiosk (each, a “Kiosk Entry”).
 - ii. At Participating Locations that do not have a GSR Kiosk or that have opted out of utilizing the GSR Kiosk for entry purposes, as reflected on Exhibit A, patrons shall enter by filling out the provided paper ballot (each, a “Ballot Entry” and together with the Kiosk Entries, collectively, the “Grand Prize Entries”). Ballot Entries must be filled out completely to be eligible. Completed entry forms must be deposited in the Promotion receptacle at the Participating Location.

All Grand Prize Entries become property of the Sponsors. For the avoidance of doubt, each Participating Location will offer only one (1) method of entry for the Grand Prize Giveaway, which will be reflected on Exhibit A. Each Participant is limited to one (1) Grand Prize Entry per Participating Location per calendar day.



- b. Social Media Giveaway: During the Social Media Giveaway Period, patrons with a personal account with Instagram may enter the social media giveaway (the “Social Media Giveaway”) by (a) finding and taking a picture with a Participating Location’s on-site Howling Fortunes Magnet (the “Magnet Photo”) and (b) visiting Instagram and (i) finding and following @grgamingil and @igtgamingna; (ii) posting such picture on the patron’s Instagram feed (the “Instagram Post”); (iii) using the hashtag #WolfPeak and mentioning the Participating Location in the caption; and (iv) tagging @grgamingil and @igtgamingna in the Instagram Post (each, a “Social Media Entry”, and collectively “Social Media Entries”). Each Participant is limited to one (1) Social Media Entry per calendar day. To obtain an account on Instagram, become a registered user by visiting www.Instagram.com.

Entries that are incomplete, illegible, misspelled, damaged, destroyed, late, misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Promotion, at the Sponsor’s sole and absolute discretion. Attempts made by the same individual to submit multiple entries by using multiple Instagram accounts, emails, addresses or other means may be disqualified. Entries generated by any automated means are void and may be disqualified. All entries submitted via Instagram are subject to Instagram’s data policy and terms of use which can be found at <https://privacycenter.instagram.com/policy> and <https://help.instagram.com/581066165581870>, respectively.

- c. Gold Standard Rewards Giveaway: During the Gold Standard Rewards Giveaway Period, patrons may enter the Gold Standard Rewards giveaway (the “Gold Standard Rewards Giveaway”) through an on-site entry at a Participating Location with a GSR Kiosk, as reflected on Exhibit A, during each Participating Location’s regular business hours as follows:
- i. Redeem a Promotion Check-In Entry: Eligible Entrants who check-in on the GSR Kiosk during the Gold Standard Rewards Giveaway Period can select the “Promos/Offers” option and redeem the entry (each, a “Gold Standard Rewards Entry”, and collectively “Gold Standard Rewards Entries”). Each Participant is limited to one (1) Gold Standard Rewards Entry per calendar day via the “Promos/Offers” section.
 - ii. Redeem a Check-In/Out Promotion Prize Entry: Eligible Entrants who check-in at a Participating Location and participate in the daily check-in/out game(s) may receive one or more bonus Gold Standard Rewards Entries as part of the Check-In/Out Promotion (as defined in the Official Gold Standard Rewards Player Rewards Program Rules). Eligible Entrants may enter the Gold Standards Rewards Giveaway by properly redeeming such bonus entries at the Participating Location within the Gold Standard Rewards Giveaway Period. For the avoidance of doubt, a Participant can redeem both the Gold Standard Rewards Entry received from the “Promos/Offers” section and any bonus entries on the same calendar day.



In the event that a Participant does not comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsors, such Participant may be disqualified from the Gold Standard Rewards Giveaway. Moreover, at the sole determination of the Sponsors, all of that Participant’s entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prize.

Upon completion of the promotion procedures outlined in Section 4 above, Participant will be automatically entered into the Grand Prize Giveaway, Social Media Giveaway and/or Gold Standard Rewards Giveaway, as applicable.

5. SELECTION OF WINNERS:

- a. Grand Prize Giveaway: On Thursday, October 26, 2023, at approximately 6:00 p.m. CST, four (4) Grand Prize Entries will be randomly selected by a representative of each Participating Location (each, a “Finalist Prize Winner”, and collectively the “Finalist Prize Winners”). On Thursday, November 2, 2023, at approximately 6:00 p.m. CST via Gold Rush Gaming’s Facebook page (the “Grand Prize Drawing”), a representative from Gold Rush Gaming will randomly select one (1) Finalist Prize Winner from each region (each, a “Regional Prize Winner”, and collectively the “Regional Prize Winners”) for a total of three (3) Regional Prize Winners. Finalist Prize Winners will be separated into one (1) of three (3) regions based on the Participating Location from which they were selected: Central, Western and Southern, as reflected on Exhibit A. Once Regional Prize Winners have been randomly selected, all remaining Finalist Prize Winners will be combined, and a representative from Gold Rush Gaming will randomly select one (1) winner (the “Grand Prize Winner”) for the Grand Prize (as defined below).
- b. Social Media Giveaway: Each Monday (as detailed below) at approximately 12:00 p.m. CST throughout the Social Media Giveaway Period (each, a “Social Media Drawing”), a representative of Gold Rush Gaming will randomly select six (6) winners (each, a “Social Media Winner”, and collectively the “Social Media Winners”) from all Social Media Entries for a total of thirty (30) Social Media Winners by Monday, October 30, 2023, at approximately 12:10 p.m. CST.

- c. Gold Standard Rewards Giveaway: On days detailed below at approximately 12:00 p.m. CST throughout the Gold Standard Rewards Giveaway Period (each, a “Gold Standard Rewards Drawing”), a representative of Gold Rush Gaming will randomly select five (5) winners (each, a “Gold Standard Rewards Winner”, and



collectively “Gold Standard Rewards Winners”) from all Gold Standard Rewards Entries for a total of twenty-five (25) Gold Standard Rewards Winners by the conclusion of the Gold Standard Rewards Giveaway Period.

By entering this Promotion, each Participant agrees that (A) they have read and accepted these Official Rules; (B) they have read and accepted the Official Gold Standard Rewards Player Rewards Program Rules; (C) they have read and accepted the Gold Rush Player Rewards privacy policy, which is available at www.goldrushgaming.com/privacy-policy/; and (D) they have read and accepted the Gold Rush Player Rewards Terms of Use, which is available at www.goldrushgaming.com/terms-of-use/, which is incorporated by reference and made a part of these Official Rules. **Participant is eligible to be a Finalist Prize Winner at each Participating Location one time. Participant is eligible to be a Regional Prize Winner one time. Participant is eligible to be a Grand Prize Winner one time. Participant is eligible to be a Social Media Winner one time. Participant is eligible to be a Gold Standard Rewards Winner one time.**

6. NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS PROMOTION. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, PLAY OF VIDEO GAMING TERMINALS OR THE PURCHASE OF ANY PRODUCT, GOOD OR SERVICE SOLD BY ANY SPONSOR) WILL NOT IMPROVE A PARTICIPANT’S CHANCES OF WINNING A PRIZE IN THIS PROMOTION.

7. **PRIZES, PRIZE VALUES, ODDS OF WINNING AND COLLECTING PRIZES:**
The following outlines the prize distribution:

- a. Finalist Prize Winners: Four (4) One Hundred Dollar (\$100.00) cash prizes will be given away on Thursday, October 26, 2023, at approximately 6:00 p.m. CST at each Participating Location. The total number of Finalist Prize Winners will depend on the number of Participating Locations.
- b. Social Media Prize Winners: A total of thirty (30) Five Hundred Dollar (\$500.00) cash prizes will be given away (six (6) Social Media Winners each Monday at approximately 12:00 p.m. CST on the dates set forth in Section 5(b).
- c. Gold Standard Rewards Winners: A total of twenty-five (25) sets of four (4) tickets to the Terror Roulette Haunted House will be given away by the conclusion of the Gold Standard Rewards Giveaway Period in the form of unique promotional codes (five (5) Gold Standard Rewards Winners each previously specified day at approximately 12:00 p.m. CST throughout the Gold Standard Rewards Giveaway



Period). Each Gold Standard Rewards Winner will win four (4) tickets to the Terror Roulette Haunted House in the form of a unique promotional code. Each Gold Standard Rewards Winner is responsible for booking their own visit and using the code provided. The Terror Roulette Haunted House is located in The Arboretum of South Barrington at 100 West Higgins Road, South Barrington, IL 60010. The Approximate Retail Value (“ARV”) of each ticket is Forty-Two Dollars (\$42.00) for a collective ARV of Four Thousand Two Hundred Dollars (\$4,200.00) in prizes.

The odds of a Grand Prize Entry, Social Media Entry and/or Gold Standard Rewards Entry being randomly selected as the Finalist Prize Winner, Social Media Winner and/or Gold Standard Rewards Winner, respectively, depends entirely on the number of Grand Prize Entries, Social Media Entries and/or Gold Standard Rewards Entries received during the applicable Promotion Period. Finalist Prize Winners, Social Media Winners and Gold Standard Rewards Winners will be randomly selected.

- d. Regional Prize Winners: Each Regional Prize Winner shall win a cash prize of Ten Thousand Dollars (\$10,000.00) (each, a “Regional Prize”, and collectively the “Regional Prizes”) for a total of three (3) Regional Prize Winners and a collective Thirty Thousand Dollars (\$30,000.00) in Regional Prizes awarded. The odds of winning a Regional Prize depend on the number of Participating Locations in such region, as set forth on Exhibit A. There will be one (1) Regional Prize Winner from each region.
- e. Grand Prize Winner: The Grand Prize Winner shall win a cash prize in the amount of Twenty-Five Thousand Dollars (\$25,000.00) (the “Grand Prize”). The odds of winning the Grand Prize depend on the number of Participating Locations, as set forth on Exhibit A. There will be one (1) Grand Prize Winner.

A representative of Gold Rush Gaming will conduct the Regional Prize Drawing and the Grand Prize Drawing. The Regional Prizes and the Grand Prize may not be transferred and must be accepted as awarded. It is the Participant’s responsibility to read and understand all information.

- f. All costs and expenses associated with a Participant’s acceptance, collection and use of a prize not specified herein as being provided as part of the prize are the sole responsibility of the winning Participant.
- g. Grand Prize Winner, Regional Winners, Social Media Winners, Gold Standard Rewards Winners and Finalist Prize Winners will be required to verify eligibility, as discussed above in Section 2, and if he/she does not produce proof of such documentation, an alternative winner may be selected and the original winner’s rights to the prize will be automatically forfeited.



8. PRIZE WINNERS' NOTIFICATION PROCEDURES:

- a. Finalist Prize Winners will be notified by a representative of the Participating Location that selected the Finalist Prize Winner by telephone at the telephone number used in connection with the Kiosk Entry or the Ballot Entry, as applicable, no later than twenty-four (24) hours from the time the drawing was conducted. Each Finalist Prize Winner will have forty-eight (48) hours to collect his or her prize from the Participating Location. In the event that the Finalist Prize Winner has entered an invalid telephone number, such Participant shall be disqualified from the Finalist Prize Giveaway, the Regional Prize Giveaway and the Grand Prize Giveaway, and Sponsors shall have the discretion to select a new winner.
- b. Social Media Prize Winners will be notified by a representative of Gold Rush Gaming via a direct message to the Instagram account with which he/she entered the Promotion no later than twenty-four (24) hours from the time the applicable Social Media Drawing was conducted. Each Social Media Winner will have five (5) days from the time the direct message was sent to respond to the direct message and claim the prize. If a Social Media Winner does not respond within the applicable claim period, his or her prize shall be forfeited and a secondary drawing may occur, at the sole discretion of Gold Rush Gaming.
- c. Gold Standard Rewards Prize Winners will be notified by a representative of Gold Rush Gaming by telephone at the telephone number used in connection with the winner's GSR Program account no later than twenty-four (24) hours from the time the applicable Gold Standard Rewards Drawing was conducted. Each Gold Standard Rewards Winner will have five (5) days from the time the phone call was made to respond to the phone call. If a Gold Standard Rewards Winner does not collect the prize within the applicable claim period, the prize shall be forfeited and a secondary drawing may occur, at the sole discretion of Gold Rush Gaming. The Gold Standard Rewards Winner will then be sent an email with their unique promotional code and instructions regarding how to claim their tickets. Date and time subject to availability. Each Gold Standard Rewards Winner must visit www.terrorroulette.com to book their Terror Roulette Haunted House visit, use the unique promotional code provided to claim their tickets at checkout and place their order. Each Gold Standard Rewards Winner must book their own Terror Roulette Haunted House visit, without exception, before Tuesday, October 31, 2023. Failure to book the Terror Roulette Haunted House visit in the applicable period for any reason will result in forfeiture of the tickets, and a cash value will not be provided. Sponsors are not responsible for any failure or inability to book the Terror Roulette Haunted House visit. Tickets to the Terror Roulette Haunted House are subject to certain terms, conditions, releases and waivers specified thereon.
- d. Grand Prize Winner and Regional Prize Winners will be announced on Gold Rush Gaming's Facebook page, and a representative of Gold Rush Gaming will contact the Grand Prize Winner and each Regional Prize Winner at the telephone number used in connection with the Kiosk Entry or the Ballot Entry, as applicable, no later



than forty-eight (48) hours from the time the drawing was conducted. A winner must complete a W9 form if the prize amount exceeds six hundred dollars (\$600.00). The Grand Prize Winner and each Regional Prize Winner shall have five (5) days from the time of the drawing to make arrangements with a Gold Rush Gaming representative to collect the prize at a Participating Location.

- e. Grand Prize Winner, Regional Prize Winners, Social Media Winners, Gold Standard Rewards Winners and Finalist Prize Winners must complete either an “Affidavit of Eligibility” and/or a “Receipt, Release and Discharge form” before accepting his or her prize.
9. **CONDITIONS:** All taxes, costs, and other expenses not otherwise set forth herein are the sole responsibility of each winner. Each Regional Prize Winner and Grand Prize Winner will be required to provide tax information and will be sent an IRS Form 1099. Each winner is solely responsible for reporting and paying all applicable federal, state and local taxes related to the prize. No prizes are transferable.

10. MISCELLANEOUS:

- a. By entering the Promotion, each Participant unconditionally agrees to be bound by these Official Rules and the decisions of the Sponsors, which shall be final. The Sponsors reserve the right to disqualify any Participant or Grand Prize Winner, Regional Winners, Social Media Winners, Gold Standard Rewards Winners and/or Finalist Prize Winners who, in Sponsors’ sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner. In the event of a discrepancy between these Official Rules and any creative/collateral materials relating to this Promotion, these Official Rules will prevail.
- b. All federal, state, and local laws apply, and all applicable federal and state taxes are the sole responsibility of the Grand Prize Winner, Regional Winners, Social Media Winners, Gold Standard Rewards Winners and Finalist Prize Winners.
- c. The Sponsors and, as applicable, Promotion Parties are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) any condition caused by events beyond the control of the Sponsors that may cause this Promotion to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in this Promotion; (iv) any printing or typographical errors in any materials associated with this Promotion, or (v) late, lost, delayed, or damaged delivery of the prize. Sponsors reserve the right, at their sole discretion, to suspend, modify or terminate this Promotion (or portion thereof) for any or no reason, including if Sponsors



determine that any portion of this Promotion is compromised for any reason, and, if terminated, at the Sponsors' discretion, Sponsors may select the potential winner(s) for the drawing(s) at issue from among all non-suspect, eligible entries received for the applicable drawing(s) prior to action taken. CAUTION: ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THIS PROMOTION MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSORS RESERVES THE RIGHT TO SEEK ANY AND ALL REMEDIES AVAILABLE FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW.

- d. For the name of the winner(s) or an additional copy of the Official Rules, send a self-addressed stamped envelope request to Gold Rush Gaming at Gold Rush Gaming's Main Office.

11. **SOCIAL MEDIA DISCLOSURE:** Although this Promotion may be advertised on the Facebook pages, Twitter accounts, Instagram accounts, YouTube channel or other social media platforms of Sponsors, this Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram, YouTube or other social media platforms. Participants are providing their information to the Sponsors and not to Facebook, Twitter, Instagram, YouTube or other social media platforms. The information a Participant provides will only be used by the Sponsors and its agents. By entering, Participants provide a complete release of Facebook, Twitter, Instagram or YouTube from any and all responsibilities implied or provided by the Sponsors and that this Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram or YouTube.

12. **USE OF DISCLOSED INFORMATION:** Information transmitted to Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, required Participant information, biographical information and/or likeness for online posting and /or any other written or photographic advertising and publicity without additional compensation. Further, by entering this Promotion, the Participant is granting the Sponsors permission to use his/her contact information to (i) contact him/her regarding a prize, and (ii) provide him/her with marketing or other informational materials related to the Sponsors.

13. **ARBITRATION:** Except where prohibited by law, as a condition of participating in this Promotion, Participant agrees that: (a) any and all disputes and causes of action arising out of or connected with this Promotion, or any prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the Sponsors; (b) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (c) judgment upon such arbitration



award may be entered in any court having jurisdiction. Under no circumstances will a Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Participant's actual out-of-pocket expenses (i.e., costs associated with participating in this Promotion), and Participant further waives all rights to have damages multiplied or increased.

14. **CHOICE OF LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Participant and Sponsors in connection with this Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Illinois, USA. This Promotion is subject to compliance with the Illinois Video Gaming Act and the rules and regulations promulgated thereunder.
