

**“GAS N WASH Q1 2025 PROMOTION”
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. GAS N WASH Q1 2025 PROMOTION OVERVIEW:** The “GAS N WASH Q1 2025 PROMOTION” (this “Promotion”) is sponsored by Gold Rush Amusements, Inc. (“Gold Rush Gaming”), Accel Entertainment Gaming, LLC (“AE”) and each of the locations set forth on Exhibit A, attached hereto, that are serviced by Gold Rush Gaming or AE, as applicable (each, a “Participating Location”, collectively the “Participating Locations”, and together with Gold Rush Gaming and AE, the “Sponsors”). Gold Rush Gaming’s principal place of business is located at 5277 Trillium Blvd., Hoffman Estates, IL 60192 (“Gold Rush Gaming’s Main Office”) and AE’s principal place of business is located at 140 Tower Drive, Burr Ridge, IL 60527 (“AE’s Main Office”).
- 2. ELIGIBILITY:** Patrons may enter this Promotion through an on-site entry via the Gold Rush Player Rewards Program or the AE Player Rewards Program, as applicable, as described below (each, an “Entry”, and collectively “Entries”). This Promotion is open to patrons of each Participating Location who are (i) enrolled in the Gold Rush Player Rewards Program or the AE Player Rewards Program, as applicable (regardless of whether such patron has or intends to play a video gaming terminal or otherwise make a purchase); (ii) if enrolled in the Gold Rush Player Rewards Program, a resident of Illinois, Wisconsin or Indiana; (iii) if enrolled in the AE Players Reward Program, a resident of Illinois, Indiana, Iowa, Kentucky, Michigan, Minnesota, Missouri, Tennessee, or Wisconsin; and (iv) twenty-one (21) years of age or older at the time of entry (an “Eligible Entrant”). Patrons may be required to show a valid identification card (either a driver’s license or other government issued photo identification) with the patron’s picture, name, address and date of birth at the time of Entry to participate. Each person who enrolls in this Promotion is referred to herein as a “Participant”. The following persons are ineligible to participate in this Promotion and/or to win a prize, even if they otherwise meet the definition of an Eligible Entrant: employees, officers, directors, agents, owners, successors and assignees of the Sponsors, their respective parent, subsidiaries and affiliated companies, any advertising, promotional agencies, or other entity otherwise involved in the creation,

administration or fulfillment of this Promotion (all of the above entities mentioned in Section 1 collectively referred to herein as “Promotion Parties”), and the immediate family members (defined as spouse, parent, child, sibling, or grandparent; whether biological adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as an Eligible Entrant at any time during the Promotional Period, as defined below) of such Promotion Parties. Each Participant is limited to creating one (1) account for the Gold Rush Player Rewards Program and one (1) account for the AE Player Rewards Program.

3. **PROMOTION DATES:** This Promotion will begin on Sunday, March 1, 2025, at approximately 12:01 a.m. CST and conclude on Wednesday, April 30, 2025, at approximately 11:59 p.m. CST (the “Promotion Period”). At approximately 12:00 p.m. CST on Tuesday, April 1, 2025, and Thursday, May 1, 2025 (each, a “Secondary Prize Drawing”), one (1) Entry will be selected as a winner from each Participating Location (each, a “Secondary Prize Winner”, and collectively the “Secondary Prize Winners”). A Participant need not be present to be selected as a Secondary Prize Winner. On Thursday, May 15, 2025, at approximately 6:00 p.m. CST at LENNY’S GAS N WASH LAGRANGE ROAD, LLC dba Lenny’s Gas N Wash LaGrange Road, located at 19990 South La Grange Road, Mokena, IL 60448 (the “Grand Prize Drawing”), each of the Secondary Prize Winners will be eligible to win the Grand Prize (as defined below). A Secondary Prize Winner must be present to be selected as a Grand Prize Winner (as defined below). If a Secondary Prize Winner is unable to attend, they can send a representative on their behalf, in which case they must notify either Gold Rush Gaming or AE, forty-eight (48) hours prior to the Grand Prize Drawing. A representative is not eligible to become the Secondary Prize Winner or Grand Prize Winner and cannot win the prizes. To inform the relevant party of your designated representative, kindly direct your inquiries to the team member who apprised you of your finalist position via the email or phone number provided to you. Representatives must be twenty-one (21) years of age or older at the time of the Grand Prize Drawing to be eligible to represent a Secondary Prize Winner. Representatives and Secondary Prize Winners will be required to show a valid identification card (either a driver’s license or other government issued photo identification) with their picture, name, address and date of birth at the Check-In Table before the Grand Prize Drawing to verify eligibility.
4. **PROMOTION PROCEDURES:** Patrons may enter this Promotion by visiting a Participating Location and accessing the Gold Rush Player Rewards Program or the AE Player Rewards Program, as applicable, that is available at the designated kiosk near the gaming area at the Participating Location during normal business hours.

- a. Participants entering via the Gold Rush Player Rewards Program can enter this Promotion as follows:
 - i. Redeem a Promotion Kiosk Check-In Entry: Eligible Entrants can check-in on the Player Rewards Kiosk at the Participating Location during the Entry Period. Eligible Entrants can view the “Promos/Offer” section in their account to select the “Redeem Promotion Entry” option for entry into the Promotion. Eligible Entrants are allowed to redeem one (1) Kiosk Promotion Check-In Entry per day.
 - ii. Redeem Kiosk Check-In/Out Promotion Prize Entry: Eligible Entrants that check-in at a Participating Location and participate in the daily check-in/out game(s) may receive one or more entries as part of the Check-In/Out Promotion (as defined in the Official Gold Standard Rewards Player Reward Program Rules). Eligible Entrants may enter the Promotion by properly redeeming such vouchers at the Participating Location within the Promotional Period. Entries must be redeemed in the month awarded.
- b. Participants entering via the AE Player Rewards Program will be automatically entered into this Promotion upon completion of a valid check-in at the Participating Location by either entering all requested information on the AE Rewards Program kiosk, where available, and submit as directed, or via the AE Player application on a compatible smart phone device while physically located inside the Participating Location. Participants are limited to one (1) check-in Entry per person per one (1) hour period per Participating Location.

Following the selection of the Secondary Prize Winners, all Entries submitted prior to such Secondary Prize Drawing will be discarded. In the event that a Participant does not comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsors, such Participant shall be disqualified. Each Secondary Prize Winner shall be notified by telephone call, using the Secondary Prize Winner’s telephone number on the Gold Rush Player Rewards Program’s or the AE Player Rewards Program’s system, as applicable. In the event that the Secondary Prize Winner has entered an invalid telephone number, such Participant shall be disqualified from this Promotion, and a new winner shall be selected. Moreover, at the sole determination of the Sponsors, all of that Participant’s Entries may be deemed null and void, not honored or acknowledged, and may be grounds for forfeiture of his/her prize. By entering this Promotion, each Participant agrees that (A) they have read and accepted these Official Rules; (B) they have read and accepted the Official Gold Rush Player Rewards Rules and/or the Official AE Player Rewards Rules, as applicable; (C) they have read and

accepted Gold Rush Player Rewards and/or AE Player Rewards privacy policy, as applicable, which is available at www.goldrushgaming.com/privacy-policy/ and www.aeplayer.com/privacy-policy/; and (D) they have read and accepted Gold Rush Player Rewards' and AE Player Rewards' Terms of Use, as applicable, which are available at www.goldrushgaming.com/terms-of-use/ and www.aeplayer.com, both of which are incorporated by reference and made a part of these Official Rules. **A Participant is eligible to be a Secondary Prize Winner one (1) time. If a Secondary Prize Winner's name is drawn again/repeated, a new winner shall be selected.**

6. **PRIZES, PRIZE VALUES, ODDS OF WINNING AND COLLECTING PRIZES:**

- c. On Thursday, May 15, 2025, at approximately 6:00 p.m. CST, a designated Sponsor team member or manager will select at random, from all eligible Secondary Prize Winners, five (5) Grand Prize Winners (each a “Grand Prize Winner”, and collectively the “Grand Prize Winners”) beginning in reverse order with the fifth place prize and concluding with the first place Grand Prize Winner. The Sponsor employee or representative will conduct the Grand Prize Drawing. The Grand Prize may not be transferred and must be accepted as awarded. It is the Participant’s responsibility to read and understand all information, if any, which accompanies the Grand Prize. A Grand Prize Winner will be required to verify eligibility and to show a valid identification card (either a driver’s license or other government issued photo identification) with the patron’s picture, name, address, and date of birth at the Grand Prize Drawing; if a Grand Prize Winner is unable to verify eligibility, an alternative winner may be selected and the original winner’s rights to the Grand Prize will be automatically forfeited.

Gold Rush Gaming and AE, as applicable, will send the winner a W9, which must be completed and returned to Gold Rush Gaming and/or AE, as applicable, for the winner to receive the Grand Prize. The Sponsors reserve the right at their sole discretion to suspend, modify or terminate this Promotion (or portion thereof) for any or no reason, including if the Sponsors determines that any portion of this Promotion is compromised for any reason, and, if terminated, at the Sponsors' discretion, the Sponsors may select the potential winner(s) for the drawing(s) at issue from among all non-suspect, eligible entries received for the applicable drawing(s) prior to action taken. Participants are providing their information to the Sponsors and not to Facebook, X, Instagram, YouTube or other social media platforms. The information a Participant provides will only be used by the Sponsors and its agents. By entering into this Promotion, Participants provide a complete release of Facebook, X, Instagram or YouTube from any and all responsibilities implied or provided by the Sponsors and that this Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, X, Instagram or YouTube.
11. **USE OF DISCLOSED INFORMATION:** Information transmitted to the Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, biographical information and/or likeness for online posting and /or any other written or photographic advertising and

publicity without additional compensation. Further, by entering this Promotion, a Participant is granting the Sponsors permission to use his/her contact information to (i) contact him/her regarding a prize and (ii) provide him/her with marketing or other informational materials related to the Sponsors.

13. **CHOICE OF LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Participant and the Sponsors in connection with this Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Illinois, USA. This Promotion is subject to compliance with the Illinois Video Gaming Act and the rules and regulations promulgated thereunder. 14. **SEVERABILITY:** If any provision(s) of these Official Rules is held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect. The Sponsors reserve the right in its sole discretion to supplement or make changes to these Official Rules without notice.
